October 9th was a proud day for Eagle Crest Communities as we gathered at Eagle Crest North to celebrate the groundbreaking of our "Eagle Crest North expansion". Eighteen years ago, we also gathered at this site to celebrate groundbreaking for Eagle Crest North our first Eagle Crest Community. Eagle Crest North was designed to be a visionary new community for senior living offering a lifestyle and amenities typically only

found in large cities and requiring big entry fees to live there. We were able to accomplish our vision and expand that vision adding Eagle Crest South Phase I and Phase II in La Crosse. Now we are back in Onalaska where it all started.

Eagle Crest North is a 11.44-acre park like campus. The cost will be \$25.9 million dollars with Eagle Crest Communities contributing \$5,180,000 as an equity contribution. This equity contribution is not built into the rates making it affordable for most income levels. This expansion will include 87 independent living apartment homes ranging in size from 758 to 1653 sq ft, all with quartz countertops and fireplaces. The new Village Square will include a Virtual Sports Lounge with a golf simulator and other virtual reality activities.

The building will be five stories tall and attached to our existing building offering beautiful views of Lake Onalaska and the surrounding bluffs.

Another added benefit is the location – being across the street from the YMCA and a short distance from local medical centers, shopping, banking and local entertainment.

Construction began in late September and we plan to open the new campus in January 2026.

Eagle Crest Communities has grown to be an organization of regional renown and is the 134th largest non-profit senior care provider in the country.

We are very proud to be able to expand on our Eagle Crest vision and provide this wonderful quality of life for the seniors in the Coulee Region.

Higher, Deeper, Farther: The chaplain's role in providing pastoral care to the corporation we serve is one area that challenges us. Within my denomination, ELCA Lutheran, chaplains have been trained well to provide pastoral care within specialized settings. Under the guidance of gifted mentors, we've studied in some of the world's finest healthcare organizations, we've been immersed in stimulating arenas of contextual learning, and we've been privileged to learn from "living human documents" as they endured nearly every imaginable predicament.

Therein lies our strength. We have been trained to provide competent pastoral care to patients and residents, their family members, and staff.

But one area that challenges us to reach higher, deeper, and farther is providing ministry to the corporations we serve.

Harold Everson, in The Corporate Person, identifies the corporation as "a legal entity, an artificial being. To incorporate means to create a body or corpus that in the eyes of the law is every bit as legitimate and real as flesh

and blood." A faith-based organization has a particular life, and it has particular privileges, responsibilities, challenges, and commitments.

How does the chaplain care for such a body? How does she attend to the body challenged by rising costs, sinking reimbursements, shrinking workforce, and the evolution of long-term care communities? How does she help the corporation's leaders keep their bearings through the white waters of regulation and fast-changing market forces?

A first step is for chaplains to recognize that their role reaches beyond providing care to individuals seeking services, to providing care to the corporation through its leaders serving in the board room and the executive offices. The chaplain is equipped with unique gifts that allow her to listen to the struggles, tease out and articulate the critical issues, explore the riches of scripture, and bring to bear the wealth of our faithful tradition. As a result, the mission of the organization may be seen in new light and with new vision.





We who serve as chaplains to the corporation can seize opportunities to integrate heritage, mission, vision, and the day to-day practice of ministry.

For example, with governing boards and manager meetings I am invited to lead devotions. More recently, providing a ground breaking blessing for the Eagle Crest North expansion. How Riverside Responded to Support Traditions Assisted Living Residents Displaced by Fire

On Saturday, October 5th, 2024, in the late afternoon our Senior Director of Maintenance alerted our Marketing Director of a fire at Traditions Assisted Living in La Crescent. Being a mission-driven organization, our first thought was, how could we help? Our Marketing Director reached out to the Houston County Sheriff's Office for assistance, which connected us with the Manager of Traditions. We discussed the residents' needs to determine placement and offered immediate help at Riverside Transitional Care.

Missy Pohlmann, Director of Nursing, was appointed Incident Commander and reached out to the Riverside team to assess who

could assist with the emergency response. Many team members, including Missy Pohlmann, Chris Bunke, Miranda Rushlow, Lindsay Larkin, Brooke Riffey, Tiffany Marshall, Susan Boisvert, Nancy Pierce, Chang Vue, Diana Boggs, Nicole Erdman, Hannah Fort, Tina McKittrick, Marissa Sutherland, CJ Pohlmann, and Ron Kaiser, quickly stepped in that Saturday evening, alongside those already on duty. Everyone did an outstanding job organizing to provide emergency placement for eight residents.

Thanks to the quick action of the La Crescent Fire and EMS, Houston County Sheriff's Office, and support from neighboring fire departments, residents were safely evacuated to a nearby church in Houston. As a result of Riverside's regular Emergency Response training, our team was able to quickly mobilize staff and vehicles to pick up residents and welcome them with open arms upon their arrival. We assisted them with clean clothes, meals, medications, and a temporary home while collaborating with Traditions staff to ensure ongoing care within our facility. Riverside worked closely with Traditions, Inclusa Family Care, WI DHS, Family Care, and the WI Ombudsman program to secure permanent placements, relocating four residents back to the community and admitting others while continuing placement efforts.

We are grateful to help these residents, living out our mission: "Rooted in Christian Faith, Caring for Each Other, Serving the Community" and our core values of Teamwork, Respect, Integrity, Commitment, and Love. We are incredibly proud of the Riverside team—great job, everyone!
